

# **AUA Member Nomination Guidelines**

**NOMINATION REQUIREMENTS -** The following items are required for each nomination:

- 1. Nomination Letter (see suggested format below):
  - Candidates for Active, Associate or Affiliate membership must be nominated by an active member in good standing.
  - Nomination letter should describe in detail the nominee's qualifications for AUA membership, including examples of the applicant's contributions to academic anesthesiology in research, education, and/or clinical and administrative activities.
  - What accomplishments has this individual achieved in academic anesthesiology?
     Why are you recommending the individual for election to AUA membership?
- 2. Curriculum Vitae for Nominee: Attach the nominee's current CV to online form.
- 3. Additional Material for Associate Member Candidates eligible for dues-free initiative:
  - If applicable, include in the nomination letter a list of the nominee's current research funding. Funding will be verified by AUA via the funding institution.

#### SUGGESTED NOMINATION LETTER FORMAT

**First Paragraph (General Information):** Please provide the nominee's name, degrees, academic rank, departmental appointments, and university affiliations as well as the membership category being requested (Active, Affiliate, or Associate).

**Second Paragraph (Research Activities):** Please specify the number of peer-reviewed manuscripts, the number of case reports, book chapters, review articles, peer-reviewed abstracts and grants. Please comment briefly on the significance of this research to academic anesthesia/medicine.

**Third Paragraph (Educational Activities):** Please provide as much objective evidence as possible of the nominee's stature as an educator through evaluations by residents, students, peers and others. Other evidence of educational stature, such as visiting professorship and invited lectureships, should also be mentioned.

**Fourth Paragraph (Clinical Activities):** Discuss the individual's clinical activities where appropriate, including subspecialty training and evidence of expertise in one or more subspecialties.

**Fifth Paragraph (Leadership Activities):** Comment on the individual's leadership accomplishments. What administrative role does the individual play in the department, the institution, on national committees?

**Sixth Paragraph (National and International Activities):** The nominee's national and international activities, accomplishments and reputation should be discussed in this paragraph. Membership on national committees, service as an officer in national societies, membership in study sections for foundations or other granting organizations would be some examples.

Submit the nomination by filling out the online <u>AUA Nominations Form</u> and attaching the candidate nomination letter and CV.

The lists below are examples to help members review their application to ensure that their accomplishments are consistent with that of a successful application (depending on the membership level). One of these examples alone may not suffice for election to membership and not all of these are required.

Though not a guarantee of approval, T32 fellows meeting criteria for AUA associate membership will also receive dues waiver.

# **New Member Nominations Application Scoring**

### **NOMINATION SCORING SYSTEM**

Step 1: Check one box, to indicate your overall recommendation to council, regarding the nominee's application to become an AUA member:  Approve, with no reservations  Needs to be discussed (concisely state points of uncertainty in app)  Disapprove (explain weaknesses in app with review)  Abstain (state conflict)			
Step 2: Use a 5-point scale to score candidate in each of the four areas: (1) Academic Achievements, (2) Administration, (3) Educational Activities, (4) Research			
The 5-point scale - NOTE: Please provide ratings in whole numbers only. No decimal ratings. Total score range should be 5-20, across all areas.			
<ul> <li>5 indicates an exceptionally strong candidate with essentially no weaknesses.</li> <li>4 indicates a strong candidate with minor weaknesses.</li> <li>3 indicates a candidate with both strengths and weaknesses.</li> <li>2 indicates a underdeveloped candidate with some strengths but multiple or major weaknesses.</li> </ul>			
☐ 1 indicates an application with substantive weaknesses with very few strengths.			

Scores of 4 or less should be justified with explanatory comments for discussion.
